

Installation Instructions

Package Contents (IFM Part Numbers)

- 1) IFM Electronic POM POM with wire and connector.
- 2) Lamp Dimmer Unit.



CLEANING: The IFM Tufted Sensor is anti-microbial and stain resistant. It requires no cleaning. **Do not sponge or wet IFM Sensor**. The felt fabric cover is made with stain resistant fabric. The felt fabric cover can be sponged clean with a damp sponge. Do not submerge any part of the Electric POM POM or Dimmer Unit in water.

INSTALLATION:

- 1) Plug lamp into dimmer unit.
- 2) Plug POM POM into dimmer unit.
- 3) Plug dimmer unit into wall.
- 4) Touch tufted sensor area to control light level on lamp.

CLEANING: The IFM Tufted Sensor is anti-microbial and stain resistant. It requires no cleaning. POM POM and sensor can be sponged clean. Do not submerge in water.
